

# **AUSTRALIA STUDENT VISA CHECKLIST (SUBCLASS 500)**

#### 1. Acceptance and Documentation from Australian Institution

• **Confirmation of Enrolment (CoE):** Obtain your CoE from an Australian institution registered with the Commonwealth Register of Institutions and Courses for Overseas Students (CRICOS).

#### 2. Passport

• Valid Passport: Ensure your passport is valid for the entire duration of your stay in Australia.

#### 3. Visa Application Forms and Fees

- **ImmiAccount:** Create an ImmiAccount on the Australian Department of Home Affairs website to lodge your application.
- Visa Application Form: Complete the online application form for the Subclass 500 visa.
- Application Fee Payment: Pay the visa application fee and keep the receipt.

#### 4. Health and Character Requirements

- Overseas Student Health Cover (OSHC): Purchase OSHC for the entire duration of your stay.
- **Health Examination:** Undertake a health examination by an approved panel physician if required.
- Character Requirements: Provide a police clearance certificate if required.

#### **5. Financial Documents**

- **Proof of Funds:** Provide evidence of sufficient funds to cover tuition fees, living expenses, and travel costs. This can include:
  - Bank statements showing sufficient funds.
  - Sponsorship letters or affidavits of support.
  - Scholarship or financial aid documents.

## 6. Academic Documents

- **Transcripts and Certificates:** Include academic transcripts, diplomas, degrees, or certificates from the institutions you have attended.
- **English Language Proficiency:** Provide proof of English language proficiency (IELTS, TOEFL, PTE, etc.) if required by your institution.

# 7. Additional Supporting Documents

- **Genuine Temporary Entrant (GTE) Statement:** Write a statement outlining your intention to stay in Australia temporarily for study purposes.
- **CV/Resume:** A detailed CV or resume may be required.
- **Passport-sized Photograph:** Provide a recent passport-sized photograph as per Australian visa photo requirements.

## 8. Prepare for Possible Interview

- Interview Preparation: Be ready to answer questions about your course, your institution, your financial situation, and your intentions to return to India after your studies.
- **Documents for Interview:** Bring all relevant documents to your visa interview, if one is required.

## Visa Application Submission

- **Submit Application:** Lodge your completed visa application along with all required documents through your ImmiAccount.
- **Biometrics:** Provide biometrics (fingerprints and photo) at an authorized center if requested.

## Post-Visa Approval

- Travel Arrangements: Arrange for travel to Australia once the visa is approved.
- Housing and Accommodation: Confirm your accommodation in Australia.
- **Arrival Plans:** Make plans for your arrival in Australia, including airport pickup, if provided by your institution.
- **Orientation Programs:** Attend any pre-departure and arrival orientations provided by your institution.

## Checklists and Additional Information

- Validity of Financial Documents: Financial documents must be dated within 3 months of your visa application.
- **Translations:** Any documents not in English must be accompanied by a certified translation.
